**Support for Implementing the Stand-up India Programme  
In the State of Himanchal Pradesh**

As you are aware, the Stand Up India is a prestigious programme of the Govt of India, aiming at providing financial support to SC/ST and Women entrepreneurs for their new ventures (Greenfield Projects). Under this initiative, banks are encouraged to provide loan from Rs.10 lakhs to 1 crore with or without collateral security. In case a borrower is not yet ready to avail the loan, suitable handholding support is provided to him. Such handholding support could be in the form of help in project report preparation, financial literacy training, properly filling the application form, skill training, vocational training, EDP, or other similar activities. For this purpose, a lot of handholding agencies have been identified by the Govt, which include ITIs, RSETIs, vocational training institutes (including GSSS), DICs, etc.

In order to facilitate handholding of entrepreneurs and monitoring of the whole Stand Up India initiative, a portal has been developed and maintained by SIDBI which is known as [www.standupmitra.in](http://www.standupmitra.in).

The handholding agencies are expected to login on the portal regularly and see if any handholding request made by borrowers to them are pending, so that such request could be attended to. Login ID and passwords have already been issued. However, it has been noted that the number of agencies activated on the portal (which means first login by the agency) are very few. The following data pertaining to only Technical Institutions illustrates this :

HH agencies	Number of agencies registered on portal	Agencies activated on portal
Technical Institutions including ITIs (both Govt and Private)	180	18 (10%)

List of remaining 162 agencies not yet activated is enclosed.

You would appreciate that unless the above handholding agencies activate themselves on the portal and start looking at handholding requests after logging in on the portal every day, they would not be able to provide suitable handholding support to the entrepreneurs.

Without active handholding, it will be more difficult for the SC/ST/women entrepreneurs to get loans under the Stand Up India programme.
